PRIZE:

1 Grand Prize: One (1) grand prize (“**Grand Prize**”) winner (“**Winner**”) will receive a trip to a soccer match scheduled between June 1, 2026 and September 30, 2026 at a location to be determined by sponsor (“**Match**”). The Grand Prize consists of round-trip coach air transportation for Winner and Winner’s one (1) guest (“**Guest**”) (from a major airport near Winner’s home) to an airport near Match; double-occupancy, standard hotel accommodations (one room) for three (3) nights; two (2) tickets to Match for Winner and Guest; two (2) MNT Soccer Jerseys; two (2) MNT backpacks; a \$1,500 check sent with delivery signature confirmation; and specified ground transportation. Once your receipt has been validated, you will earn 100 points for each \$1.00 spent on participating products, exclusive of tax (1 cent = 1 point). **Spend 500 points in your account to receive an entry into the Promotion (“Receipt Entry”).**

2) Alternate Means of Entry: To receive one (1) entry into the Promotion without making a purchase (“Alternate Means of Entry”), visit KDPsoccersweeps.entertowinprizes.com and complete the online registration form.
